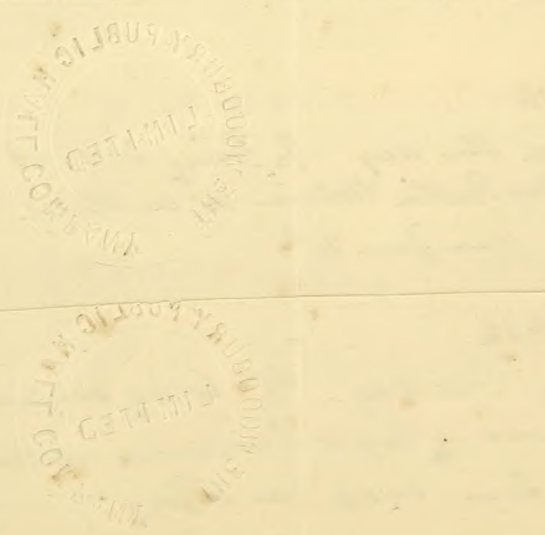

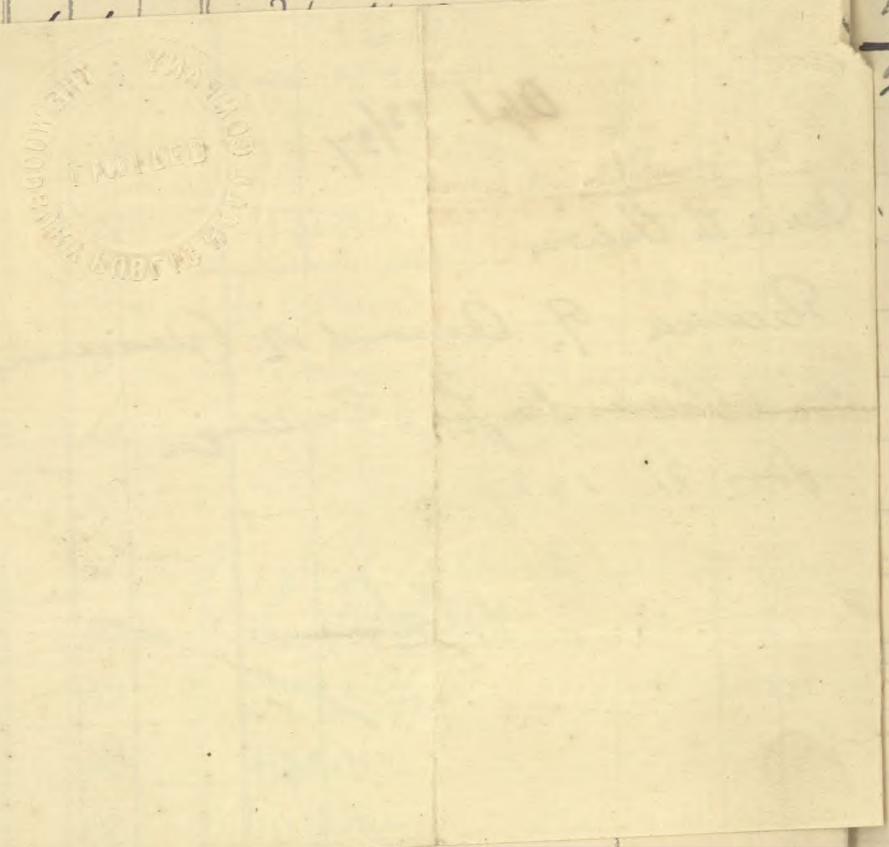

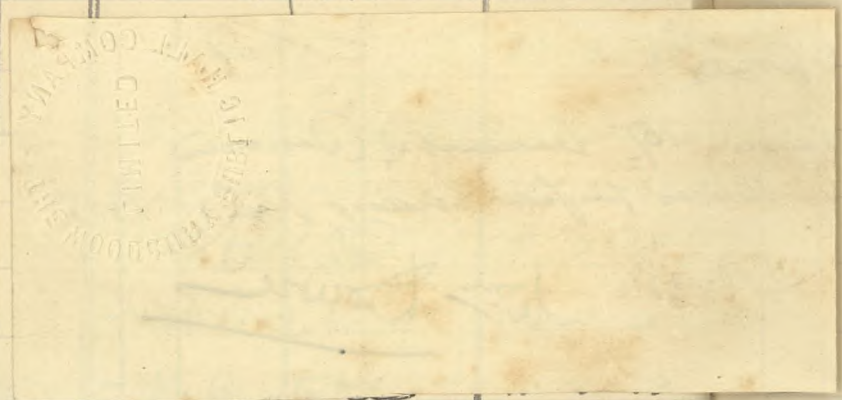

in 1 coat. When 2 coats are needed the first should be thoroughly dry before the second is applied. Before applying "Fresco" remove all loose distemper, limewash and dirt. "Fresco" can then be put straight on to the wall without any preliminary operation such as sizing, although sizing is not a disadvantage.
